ALL INTERESTED PERSONS ARE HEREBY NOTIFIED that Mead & Hunt, Inc., consulting engineers and the Town of Beaver, will host a virtual public involvement meeting for the bridge replacement on Riplinger Road. A virtual presentation will be available to view online starting Monday, June 19, 2024, at: https://www.clarkcountywi.gov/highwayprojects. For a printed version of the documents, please contact the Town of Beaver.

The proposed project consists of improving the approaches and replacing the existing structure (P-10-0937), a single-span steel girder bridge on Riplinger Road over Nelson Creek. The Riplinger Road bridge is located in Clark County, west of Riplinger, in the Town of Beaver, in Section 16, T27N, R01W. Riplinger Road will remain open during construction via a temporary bypass road. The total project length is not anticipated to exceed 150 feet. Construction for this project is currently scheduled for 2026.

The purpose of this meeting is to solicit public input on the preliminary design for this project. Persons with a concern for or knowledge about the structure and surrounding area are encouraged to review the online documents and provide comments to Mead & Hunt or the Town of Beaver




